14-169 17.0. Statutory Provisions: 17.1. Investment Clause: The Funds of the "MILANA, M.R.A.D.C., ALUMNI" shall be invested in the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act 1961 as amended from time to time. 17.2. Accounts Clause: There shall be maintained all accounts of the M.R.A.D.C., ALUMNI" regularly. The accounts shall be accounted by a Chartered Accountant. Every year the accounts shall closed by 31 March. 17.3. Amendments Clause: No amendments to the Rules and Regulations shall be made which may prove repugnant to the provisions of section 2(15), 11, 12, 13 and 80(G) of the Income Tax Act 1961, as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax. 18.0 All the incomes, earnings, movable or immovable properties or Funds and Income of the "MILANA, M.R.A.D.C., ALUMNI" shall be solely utilized for the achievement of the objects and no portion thereof shall be paid or transferred directly by way of dividends, bonus, profits or in any manner whatsoever, to the present or past members of the society or to any person claiming through any one or more of the present or the past members. No member of the society shall have any personal claim on any movable or immovable properties of the society or make any profit, whatsoever, by virtue of his membership etc. However, nothing herein contained shall prevent any payment made in good faith towards reasonable remuneration to, or willedy


