4.0. Powers and functions of the Association:

Faculty of "M.R.A.D.C." who have served at least One year are eligible to be Associate Members as long as they are in "M.R.A.D.C." or the Faculty who are superannuated from M.R.A.D.C. They will not have voting rights and they are not eligible to be considered for Distinguished Alumni Award.

5.3 Honorary Members:
All past Directors of the Dental Science are Honorary Members. They will not have voting rights and they are not eligible to be considered for Distinguished Alumni Award.

Membership Fee:
The Membership Fee as decided by the Executive Committee from time to time will prevail.

6.0. Admission of Members:
Alumni Register:

6.1. The "MILANA, ALUMNI" shall maintain a Register of all Members showing the date of admission, name, address and dates of changes of one class of Membership to another class of Membership.

6.2. Any member of "MILANA, M.R.A.D.C. ALUMNI" shall be entitled to inspect the Register of Members after due service of a notice upon the Secretary of the "ALUMNI" intimating his intention at least fifteen days prior to the date of inspection.

7.0. Management of the Association:

7.1. The affairs of the "MILANA, M.R.A.D.C., ALUMNI" shall be managed by an Executive Committee consisting of 16 members, viz., President, Two Vice-Presidents, Secretary, Joint Secretary, Treasurer and 10 Committee Members.

7.2. The members of the Executive Committee shall be elected by the Members of the Association at the Annual General Body Meeting and they shall hold office for a period of two years.

7.3 All the outgoing Executive Committee members are eligible for re-election.

7.4 The Executive Committee shall have the freedom to co-opt members from time to time for the efficient functioning of "MILANA, M.R.A.D.C., ALUMNI".

7.5 All previous Presidents of the Association shall be officio Members of the Executive Committee.

8.0. Election of the Office Bearers and Executive Committee :

8.1. The mode of election shall be by secret ballot.

8.2. The procedure of election shall be laid down by the Executive Committee including the appointment of Electoral Officer.



8.3. All terms of office of the elected members shall commence from the close of the AGBM at which elections were held and shall continue for a period of TWO YEARS or till the close of the second AGBM whichever is earlier.

8.4. Members cannot hold the same office for more than two consecutive terms.

8.5. In the event of a vacancy at any level in the Executive Committee, the Executive Committee shall have the freedom to nominate a member to fill the vacancy.

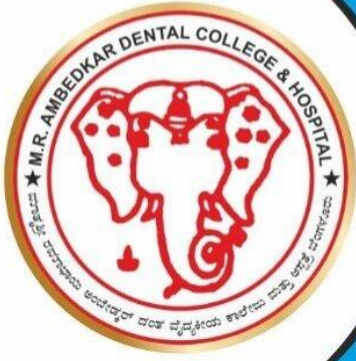
8.6. By convention, Executive Committee will select Vice-President as President-elect who will become President in the subsequent term. This will be ratified by Annual General Body.

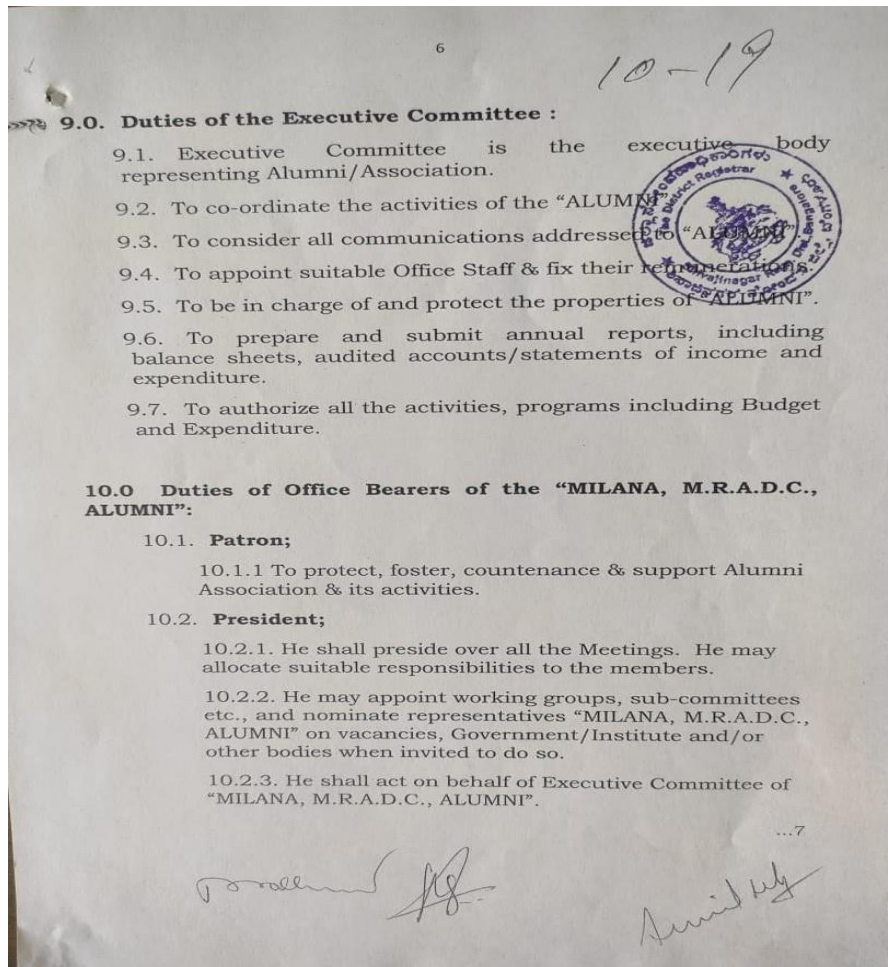

9.0. Duties of the Executive Committee :

10.3. **Vice-President;**

10.3.1. Shall act as President in the absence of the President/President elect.

10.3.2. In addition to his duties as a Member of the Executive Committee, he shall preside over the Meetings in the absence of both the President and the President-elect.

10.4. **General Secretary;**

10.5.2. He shall carry out such other duties as may be assigned to him from time to time by the Executive Committee.

10.5.3 He shall assume charge as Secretary in the absence of the Secretary or when requested to do so by the Executive Committee.

10.6 Treasurer;

10.6.1. The Treasurer shall maintain the Accounts of "MILANA, M.R.A.D.C., ALUMNI".

10.6.2. Be an ex-officio member of all Committees involving financial implications and shall be the Convener of the Finance Committee.

10.6.3. He is responsible for maintaining all the financial transactions of "MILANA, M.R.A.D.C., ALUMNI".

11.1. The Financial year of the "MILANA, M.R.A.D.C., ALUMNI" shall commence from the April 1st of a year and close on the 31st March of the succeeding year.

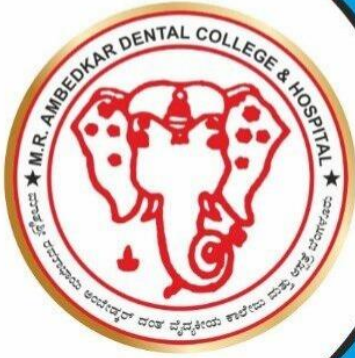

12.0. Meetings;

12.1. The General Body of the "MILANA, M.R.A.D.C., ALUMNI" shall meet at least once every year, preferably on the first day of June. Quorum for the General Body Meeting will be minimum 2/3 members.

12.2. A Special General Body may be convened at the instance of the President or the Executive Committee or by at least 1/3 Members who may give notice in writing to the Secretary.

12.3. A minimum notice of 21 days shall be given for Annual General Body Meetings and of 7 days for Special/Extraordinary General Body Meetings.



14.0. Auditors;

14.1 A certified Auditor shall be appointed by the General Body at its Annual Meeting to Audit the accounts of the "MILANA, M.R.A.D.C., ALUMNI".

15.0. Dispute;

All unresolved dispute shall be referred to Patron & his decision shall be final and binding on all parties.

16.0. Dissolution Clause;

In the event of dissolution or winding up of the "MILANA, M.R.A.D.C. ALUMNI", the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Executive Committee of the "MILANA, M.R.A.D.C., ALUMNI", but the same shall be transferred to "M.R.A.D.C.".

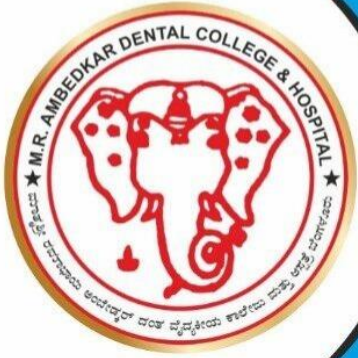

17.0. Statutory Provisions:

17.1. Investment Clause:

The Funds of the "MILANA, M.R.A.D.C., ALUMNI" shall be invested in the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act 1961 as amended from time to time.

17.2. Accounts Clause:

There shall be maintained all accounts of the "MILANA, M.R.A.D.C., ALUMNI" regularly. The accounts shall be audited by a Chartered Accountant. Every year the accounts shall be closed by 31 March.



17.3. Amendments Clause:

No amendments to the Rules and Regulations shall be made which may prove repugnant to the provisions of section 2(15), 11, 12, 13 and 80(G) of the Income Tax Act 1961, as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.

18.0 All the incomes, earnings, movable or immovable properties or Funds and Income of the "MILANA, M.R.A.D.C., ALUMNI" shall be solely utilized for the achievement of the objects and no portion thereof shall be paid or transferred directly by way of dividends, bonus, profits or in any manner whatsoever, to the present or past members of the society or to any person claiming through any one or more of the present or the past members. No member of the society shall have any personal claim on any movable or immovable properties of the society or make any profit, whatsoever, by virtue of his membership etc.

However, nothing herein contained shall prevent any payment made in good faith towards reasonable remuneration to, or

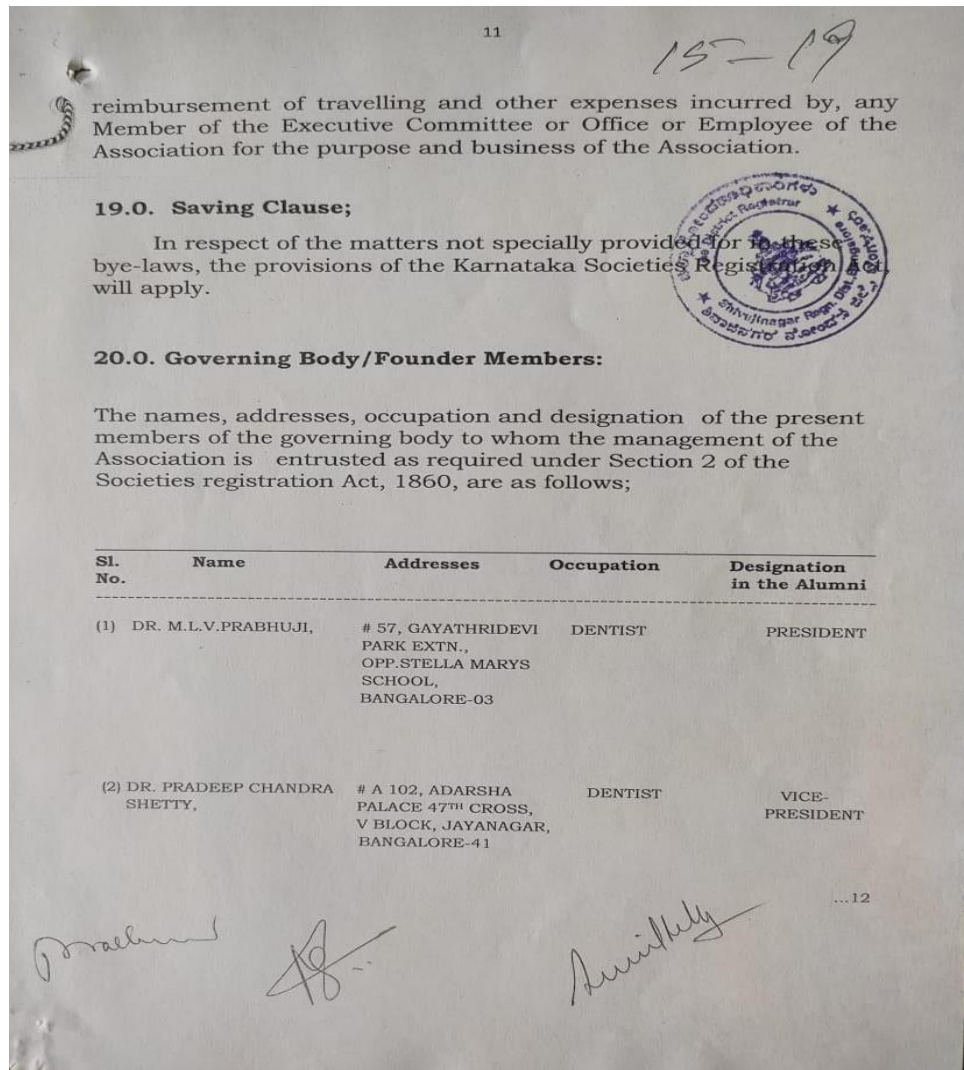
